Scope of work

1. Maintain existing camera and joystick.
2. Add ATEM TV Studio for switching.
4. Incorporate existing camera into switcher using customer's existing Magewell H26X to SDI converter.
5. ¹Add audio from X32 mixer to ATEM switcher. Using an iPad, the audio for the stream can be mixed separately from the house mix by the streaming engineer. (iPad not included in the bill of materials)
6. Add block-out headphones for streaming engineer.
7. ²Add video from presentation computer to the ATEM for switching.
8. Set up Boxcast encoder.
9. Provide power conditioner.
10. Provide three LAN drops & Audio feed to streaming control desk.
11. Provide cable protector between wall and under the control desk.
12. Relocate the electric raceway running across the audio platform and run it under the platform.

Notes: ¹Not sure about latency between camera and audio. I think this is a trial and error situation.

²Assumes that there is an existing HDMI splitter. If a splitter is not available one will have to be added to the cost.

Labor and warranties:

- SC will provide labor (except as noted) to install the system in such a manner that meets or exceeds current industry standards for similar installations.

- SC will assist St Mark's UMC in obtaining or SC will provide, at customary market rates, service for any equipment that fails after 90 Days after first use.
- Damage caused by misuse or vandalism of the system or its components is excluded from the warranty coverage listed herein.

Except as specifically provided in this Section, all loss of or damage to property and/or in respect of injury to or death of persons, caused by, arising out of, or resulting from or in connection with the installation, operation, maintenance, use, presence or removal of said System, shall be allocated as follows:
